**Application Procedure:**

1. All performances should be limited to a maximum of four (4) minutes in length, exclusive of a reasonable setup/teardown time.
2. The application should be submitted to your school, accompanied by a DVD or VHS recording of your performance.
3. All recordings submitted become the property of the Danny Marona Performing Arts Scholarship Fund, and will not be returned.
4. The deadline for application is **Friday, December 11, 2009**.

**Competition Rules:**

1. Contestants must be at least in the eleventh (11<sup>th</sup>) grade in high school or its equivalent at the time they submit their application, but must not have reached their twenty-first (21<sup>st</sup>) birthday by the date of the final competition.
2. Contestants must be a resident of the Magic Valley, Wood River Valley, or Jackpot, Nevada, and/or attending a school in one of these areas.
3. All performances must be suitable for viewing by children.
4. All decisions of the judges are final.
5. Contestants will be judged based on a variety of criteria that may include, but are not limited to, their choice of material, their ability as a performer, their appearance, their demeanor, and their audience appeal.
6. All contest winners will be expected to be reasonably available to perform at a minimum of one additional Danny Marona Performing Arts Scholarship Fund (hereinafter referred to as "The Fund") event; every effort will be made by the Fund to defray reasonable expenses incurred in this appearance.
7. All contestants agree to allow the Fund to use their likenesses and/or recordings of their performance in the Fund's promotional materials without further remuneration.
8. Except under unusual circumstances, and with the approval of the Board of Directors of the Fund, all scholarship proceeds will be paid directly to the college or other school the contestant is or will be attending.
9. Contest winners are expected to actively participate in one of the performing arts as a college student.
10. The Fund reserves the right to limit or revoke any scholarship award for reasons that include, but are not limited to:
  - A. Failure to actively participate in one of the performing arts, as deemed acceptable by the Fund
  - B. Conduct that reflects poorly on the Fund and/or its goals
  - C. Failure to be reasonably available to perform at one or more additional Fund events
